You assume full responsibility for any risk of loss; property damage; or personal injury, including the risk that you or someone you know may become infected with COVID-19, that you may sustain as a result of participating in Camp, including as a result of any related medical care. You hereby acknowledge that you know of no medical reason why you should not participate in Camp.

In consideration of being permitted to participate in Camp, you on your own behalf and on behalf of your family members, spouse, heirs, assigns and personal representatives, hereby release, waive and discharge Camp, its members, partners, affiliates, officers, agents and employees ("Releasees") from any and all liability, claims, demands, actions and causes of action of any kind or nature arising out of or related to any loss, damage or injury, including infection with or death due to COVID-19, that you or any of your property may sustain resulting from your participation in or in any way connected with your participation in Camp, regardless of whether such liability arises in tort, contract, strict liability or otherwise, and you covenant not to sue the Releasees based on the same.
- 3. You covenant and agree that this Agreement shall be construed in accordance with the laws of the State of Virginia and that any mediation, lawsuit or other proceeding relating to this Agreement and any activities covered hereby must be filed or entered into only in Virginia and the federal or state courts of Virginia. Any portion of this
